

# Stakeholder Map

## **Purposes & Benefits**

This tool provides a process for identifying the right stakeholders for a community collaborative group focused on supporting young children and families in your community to thrive.

#### **How To Use This Tool**

Sometimes when convening a collaborative group, little or no thought is put into who should be a part of it. This frequently results in a convening of "the usual suspects" and overlooks other important stakeholder groups in the community who may also have a passion for the issues related to young children and their families. This tool helps you consider who to convene for your community organizing collaborative group beyond the typical participants.

Use the stakeholder maps on the following pages to identify:

- Those with a **passion** for community organizing on issues related to young children and their families.
- Those with <u>position</u> related to addressing the needs of young children and their families.

There are two phases of stakeholder mapping included on the following pages:

- One helps identify individuals based on community sectors that are commonly focused on issues related to young children and their families in a local community.
- The other helps scan other possible allies and partners that may not yet be involved in child- and family-related issues in the local community.

In the second stakeholder map most of the categories are self-explanatory, but two of the categories, influencers and connectors, may be new to you.

- Influencers are individuals who, due to position or social capital, have the potential to influence others.
- Connectors are the individuals in every community who seem to know everyone and always have a name at the ready when asked to suggest someone who might answer a question, provide assistance, or help in other ways.

#### Who Should Serve in the Collaborative Group?

It is recommended that both stakeholder maps included in this tool be completed in order to see where the overlap is, especially in terms of those with passion. Everyone identified, regardless of passion or position, can be invited to participate in the collaborative group; however, recognize that those with a position may not necessarily be part of the core collaborative group and that is okay. Rather, they may be called in for certain aspects of the work to be accomplished (i.e., developing the community-organizing strategic plan and/or implementing pieces of the strategic plan once it is developed). Also, those without passion or position do not have to be invited to the table!



## **Map Community Sectors Stakeholder**

Use this stakeholder map to identify community stakeholders by important community sectors that often work to address issues of related to supporting children and families in your community to thrive.

As you identify people, you may want to code individuals with a passion for the issues in one color and note and those with position in another color. When completing this stakeholder map, remember these important points:

- Everyone identified, regardless of passion or position, can be invited to participate in the collaborative group; however, recognize that those with a position may not necessarily be part of the core collaborative group. Rather, they may be called in for certain aspects of the work to be accomplished (i.e., developing the community organizing strategic plan and/or implementing pieces of the strategic plan once it is developed).
- Those without passion or position (i.e., do not show up on this wheel at all) do not have to be invited to the table.
- If there are other important community sectors you need to add, simply list them by sector, subdividing each sector, adding the names of those identified with a passion for the issues and those with a position.

### **Community Sectors Stakeholder Map**

Here are eight common components of community-level early childhood systems:



Use the worksheet on the next pages to map some of the individuals in your community who work within each of these sectors, agencies, and organizations. Focus on the people who are most passionate about and/or positionally related to supporting children and families in your community to thrive.

## **Secondary Scan: Natural Allies And Possible Partners**

This next tool provides additional frameworks to help conduct a secondary scan to identify additional groups and individuals who may be involved in supporting young children and their families in the community. This scan can help



you review the sectors and determine who the most relevant people are and help prioritize those who can help you get to your goals.

Think about including adjacent communities and/or counties that you may be part of or linked with, as well as state agency and departments that influence the work. As you identify people, include those with a passion for the issues and those with position. The common groups are as follows:

Possible allies and partners	People or groups identified
Natural issue advocates

People with intersecting or overlapping issues	
(e.g, pregnancy, business people, etc.)	
Influencers – Think about these	
people both in terms of what the	
collaborative group is trying to	
accomplish but also people who	
are influential in the broader	
community in general that could	
help carry your message.	
Connectors – These are people in the local	
community who can connect you to important	
resources, including people, that you might	
otherwise have difficulty connecting to.	
Connectors are not necessarily leaders with formal	
positions in the local community.	
Content Experts – These are people with content	
expertise you need to successfully	
achieve the work of the collaborative	
group, Consider both expertise around	
topics related to the needs of children	
and families and other kinds of expertise that can	
help achieve your goals such as community	
organizers, media representatives, etc	
Persons affected/impacted by the issues related	
to young children	
and their families.	

When completing this scan, remember these important points:

- Compare the results of this map to the results from the Community Sectors Stakeholder Map, looking for an overlap of persons identified.
- Everyone identified, regardless of passion or position, can be invited to participate in the collaborative group; however, recognize that those with a **position** may not necessarily be part of the core collaborative group and that is okay. Rather, they may be called in for certain aspects of the work to be accomplished (i.e., developing the community organizing strategic plan and/or implementing pieces of the strategic plan once it is developed).
