
# ERS Assessments and Observations within LearnERS

#### **Pre-Assessment**

All Family Child Care participating in LearnERS will be observed by a BrightStars assessor using the FCCERS-3. The feedback we receive from this assessment will guide our team to provide individualized support to each program throughout the 12 months of LearnERS. It also will not negatively impact your standing with BrightStars, or your current BrightStars Rating.

#### **Post-Assessment**

A final post-assessment will be completed at the end of the 12-month enrollment into LearnERS. These reports will be evaluated with the initial pre-assessment to indicate LearnERS efficacy through classroom improvement and provider growth.



### Material Baskets

- The Navigator and Assessment teams work in collaboration
- To put together material baskets for each of the participants,
- Filled with high-quality materials.
- The first "Welcome Basket" includes materials that are generally needed by most programs
- (ex. diversity, books, math, and science materials)
- Additional material baskets will be brought to the sites midway through the year.
- These baskets will include materials specifically needed, based on the materials list created from the ERS reports.



## Peer Learning Sessions

- One hour Zoom meeting, each month
- Discussion will be focused on the content of the month's module
- Gives providers space to reflect, collaborate and share with other ECE professionals
- Providers can share their monthly goals, lessons learned from the module and reflect on any changes
- Navigators provide ERS content knowledge and coaching




